A Closer Walk

2003, (85 mins) O.V. English

A film about AIDS in the world, narrated by Glenn Close and Will Smith. Interviews with the Dalai Lama, Kofi Annan, and Bond. All these elements are woven together in a beautifully crafted film that is not only about a deadly infectious disease but a human condition. A closer walk tells us that if we act with compassion, we can put an end to the worst pandemic in history.

Age of Aids, The

2006, (240 mins) O.V. English

<u>Part 1:</u> The film traces the international response of the first uncertain years of the AIDS pandemic. This includes inspirational leadership and missed opportunities.

<u>Part 2:</u> A chasm emerges between rich and poor nations and the epidemic that threatens to explode in the "next wave" countries. How will the world handle the next phase of the age of AIDS?

Alsino y El Condor

1982, (89 mins) O.V. Spanish: no English subtitles Alsino tells the story of a young boy growing up during the Sandinista rebellion against the Somoza regime of 1970s Nicaragua. Heavy imagery denoting freedom and justice juxtapose the film's realistic portrayal of U.S. backed violence and state-violence.

Argentina: Children of the Disappeared

O.V. Spanish, English subtitles

Between 1976 and 1983, Argentina was governed by a repressive military dictatorship. This government considered students, intellectuals, and politicians as dissidents and the dictatorial government severely censored and brutalized members of these groups. An estimated 30,000 people were kidnapped, tortured, and killed during these years. Because of these atrocities, the time period is often referred to as the "Dirty War." After people marked as dissidents were kidnapped from their homes, the government usually denied any information regarding their whereabouts; as such, the murdered people were referred to as "the disappeared."

A Thousand Roads

2005, (40 mins) O.V. English, Spanish subtitles
The lives of four Native Americans take significant turns as
they confront the crises that arise in a single day. A young
Inupiat girl, a Navajo homeboy, a Mohawk stockbroker, and
a Quechua healer journey through the epic landscapes of
Alaska, New Mexico, Manhattan, and Peru, drawing
strength from their tribal pasts to transcend the challenges
of the day and embrace the promises that await them.

(90 mins) O.V. English CBC Journal Documentary

Borderless

1997, (25 mins) O.V. English

Struggles and dreams of undocumented workers in Canada. Geraldo, a Costa Rican construction worker, and Angel, a second generation Caribbean domestic worker struggle against labour exploitation.

Bordertown

2008, (114 mins) O.V. English

Starring Jennifer Lopez and Antonio Banderas, this is a powerful story of life on the border between the United States and Mexico. Bordertown is based on the tragic account of hundreds of women working in American-owned factories who have been brutally raped and murdered in Juarez, a city gripped by fear. The attacks have been covered up by the local authorities, and still continue today.

Between Midnight & the Rooster's Crow

2005, (66mins)

EnCana is a Canadian success story with a somewhat troubling history. With a market value of \$54 billion, this was the largest company in Canada (now a Chinese company). It's claim to fame; oil and natural gas. This film focuses on EnCana's development of a heavy crude oil pipeline from the Amazon across the earthquake-prone Andes to the Pacific coast for export. Since oil exploitation represents a solution for Ecuador's economic crisis, the government has gone out of its way to facilitate EnCana's plans, disregarding protests about property destruction and contamination.

Cautiva

2007, (115 mins) O.V. Spanish, Subtitles in English The film tells the story of a typical Argentine teenager whose life is suddenly uprooted when she is plucked out of class at the summons of a judge and the couple she knows as her parents are revealed to not be so. Her biological parents were "disappeared" for criticizing the military junta which had taken power in a coup. Surviving relatives of her biological parents have spent years trying to track down the child. Sent to live with her biological family since her adoption, she begins an investigation of her own in order to find out the truth. This film won the Horizons Award at the 2003 San Sebastian Film Festival and reveals the last impact of unpunished brutality on a troubled nation's soul.

What's the Cost of Your Blouse?

1993, (18 mins)

This video documents stories that deal with issues of economic justice in the workplace in the U.S and across the border, as U.S corporations move parts of their production "offshore" to cut labor costs and avoid environmental, health and safety standards. The video focuses on women garment workers in the California Bay Area, El Paso, Texas and workers in the maguiladoras on the Mexican border. The stories are told from the perspective of the human cost of the global economy.

When the Mountains Tremble

1985. PBS

This video is shot at the height of the heated battle between and heavily-armed Guatemalan Military and a nearly defenseless Mayan population. It captures the live combat footage, chaos and danger.

When the People Lead

1993, (29 mins)

For more than a decade, tens of thousands of Guatemalans have been living in Mexican refugee camps. They fled from extreme violence in Guatemala in the 1980's. This is the story of the first group of refugees returning to their homeland and the Canadian volunteers who accompanied them in rebuilding their lives in the jungle.

They Are Us

1993, (15 mins)

Canadian Auto Workers (CAW) travel to El Salvador and other countries.

Turbulence highlights the unprecedented power of the financial markets and the threats they pose to democracy.


Twenty Pieces

(26 mins)

This video tells the inside story of fashion from the workers' perspective. This is the story of the home-based outworkers who make our clothes in their homes and garages. From India to Australia, the pattern is the same: low wages, long hours, and child labor shape the garment industry. This video exposes sweatshop practices worldwide.

Canadian Learning Company 80/20-Series

A Tropical Paradise





What makes a third world country? Why are they called third world? What are the conditions in developing countries? How is Canada different? We are introduced to the concept of the developing world, the terms first, second and third worlds, and the 80/20 split where 80% of the world's population has 20% of its wealth.

Interdependence

2006, (25 mins) O.V. English

The question posed at the end of part one was why people in more developed nations should be concerned about conditions in developing nations. This program begins by examining trading relationships which appear to benefit residents of the world's richer nations more then they benefit residents of poorer nations.

Legacy of Colonialism

2006, (25 mins) O.V. English Part three of the program begins with an analysis of the historical structures which have contributed to the current status of many of the world's nations. One characteristic that most developing nations have in common is that they were at one time or another colonies or



occupied territories, and, as such, their resources were not developed for the benefit of their residents but for the benefit of an occupying power. We look at the difficulties former colonies faced after achieving independence and their susceptibility to local autocrats.

Development and Debt

2006, (25 mins) O.V. English

If the 1970s was a time of promise for many developing nations, the 80s was the decade of reversal. Part four of the series examines many of the factors which led to the "Third World Debt Crisis." It also looks at the assumption upon which foreign aid policies were based and the way in which those assumptions often contributed to new difficulties.

Where to Next?

2006, (25 mins) O.V. English

This last program in the series begins with a rehearsal of some of the greatest difficulties developing countries face as well as examples of the greatest accomplishments they have achieved. The role of NGOs (Non-Governmental Organizations) in promoting community-based social development is considered.

Central Station

1999, (106 mins) O.V. Portuguese, English subtitles The film centers on a young boy whose mother is killed in front of Rio de Janeiro's Central Station. Homeless and with nowhere to turn, he is reluctantly befriended by a lonely and cynical woman. Resisting her initial impulse to make a quick profit off the child, she commits to returning him to his father in Brazil's remote Northeast. As buses and trucks carry the motley pair through the increasingly unfamiliar terrain, they defy their initial aversion to each other, journeying closer together and deeper inside themselves. Set against an epic backdrop of vast, majestic landscapes, the trip becomes a quest for their own identities: one boy's search for his father; and one woman's search for her heart.



Spirit of the People

1998, (15 mins)

Depicts the experiences of the Horizons delegation to El Salvador in 1998 and their visits with Horizon's partner organizations in that country.

Starting Over

1994, (23 mins)

This video profiles four grassroots community organizations in Ontario working to fulfill the social and economic needs of communities and people.

Strength of Indigenous People, The

2000, (27 mins)

This video looks at the lives and work of the organic coffee producers of the Mut Vitz cooperative in the highlands of Chiapas. There are more than 1000 members and they have been producing organic coffee for the last four years.



Sweating for a T-Shirt

1998, (22 mins)

In this video, a student and her activist mother investigate where university apparel is made. This is a good resource for university and high school students.

Testimony: The Mario Guardo Story

2000, (63 mins)

This is a story of a Salvadoran activist who experienced torture and was kidnapped during the 1980's and now struggles to link human rights abuses to United States expansion.

The Silent Killer: Debt and Honduras

2001, (22 mins)

By contrasting the comments made by IMF and World Bank representatives with the stories of the people who actually live in Honduras, from peasant activists to doctors to government officials, the video shows the true impact of debt and structural adjustment programs on the country. Two compelling arguments are presented: the debt is too heavy a burden to pay, and much of that debt is illegitimate. The video ends with an eloquent plea to the international community: not for pity, but for justice.

Singing Our Stories

1998, (49 mins)

A tribute to the power of song in Native cultures-and to the women keeping these important musical traditions alive. The film is a visionary journey through the landscape of music indigenous to North America. From the Smoky Mountains of North Carolina to Vancouver Island, from the plains of Alberta to the mesas of New Mexico, *Singing Our Stories* celebrates exceptional women-their music, their heritage, their homelands-and the future of the precious musical knowledge they preserve, carry, and celebrate.


1999, (25 mins)

Today in the global economy, corporations hide their production around the world behind locked factory gates, armed guards and 15-foot high concrete walls topped with razor wire. The companies refuse to release the names and locations of the factories they use. What are they trying to hide? In this video, US students visit El Salvador maquila factories.

Coffee Comes Alive

2005, (24 mins) O.V. English

This film takes you on an engaging adventure into the mountains of southern Mexico to hear from the people who produce coffee. Learn about where coffee comes from, how it is produced, and how your coffee choices make a difference. It explores the success of one Mexican Fair Trade Coffee Coop (UCIRI) and the potential for others.

Cortos Que Animan(Stories that Entertain)

(30 mins) O.V. Spanish, English subtitles

This collection is an original and innovative experience made by the Footprint Foundation. It consists of five short films made with different animation techniques geared for youth. Each story develops specific aspects of HIV/AIDS, such as the importance of testing for HIV and the use of contraception; alcohol, drugs and their relationship with HIV; women and HIV; life with HIV and transmission from mother to child.

Crime of Padre Amaro, The

2002, (120 mins) O.V. Spanish, English subtitles Stars Gael Garcia (Amores Perros) as the main character. He's a newly ordained priest sent to work in a small church community in Mexico by the Bishop. He arrives wide eyed and full of optimism hoping to serve God and his parish. However he quickly butts heads with the elder priest in charge, Father Benito. Benito is known to accept drug money from the local drug lord in order to subsidize the construction of a new hospital and, in addition, is carrying on an affair with a local woman. To complicate matters, father Amaro soon finds himself in a love affair with the young Sunday school teacher.

De Nadie (Border Crossing)

2007, (84 mins) O.V. Spanish, English subtitles
This documentary depicts the difficult journey and struggle
of immigrants trying to make it to the U.S through Mexico
and Central America. It provides troubling insight into the
abuse that is suffered at the hands of Mexican
authorities.

<u>Demystifying the dark side of the Economy:</u> Women in Search of Alternatives

2006, (43 mins) O.V. English—Comes with a Guide This DVD and its methodology is a resource for women in community organizations that

are fighting for their rights. This video discusses an economic system that often discriminates against women, and how women are fighting for an equal distribution of work and wealth.

School of Assassins

1994, (18 mins)

Since 1946, the United States Army School of the Americas has trained thousands of Latin American and Caribbean soldiers. Among them, as we learn in the film, are the former dictators of Argentina, Bolivia, Honduras and Panama.

Searching for Hawa's Secret

1999, (46 mins)

This film tells the remarkable story of the scientific quest to find a prevention rather that a cure: a difficult endeavor when vaccine research gets only one percent of AIDS research funding globally. Despite funding inequities the work in Nairobi has shifted the paradigm of AIDS research, and has scientists across the globe seeking and finding similar groups with the natural immunity. It is also the human story of an unlikely partnership between a Canadian doctor and a Kenyan prostitute.

Seeing Windows "Los Muros"

(60 mins)

Senorita Extraviada, Missing Young Woman

2001, (74 mins)

This documentary tells the story of over 370 kidnapped, raped, and murdered young women of Juarez, Mexico.

Silence of Neto, The

1994, (106 min)

This politically-charged story tells of a young boy striving to follow his dreams while his country struggles to preserve democracy amidst CIA cold-war propaganda.

The Revolution Will Not Be Televised

2002, (75 mins.)

This film goes inside the April 2002 attempt to over throw Hugo Chavez, president of Venezuela.

Sacred Land, Scarred Land

2000, (17 mins)

In this video, four communities are visited: the Lubicon in Alberta, the Embera Katio in Colombia, the Nuer in Sudan, and the people of Marinduque, Philippines, to hear first-hand the stories of their struggles to maintain their land rights, livelihoods, and cultural identities in the face of corporate intrusions.

Sanctuary

1983, (30 mins)

This video tells the story of an American church congregation, that decided to give sanctuary to a refugee family from El Salvador, even though they knew they were breaking the law.

Sandbaggers

(12:43 mins) CBC News World Documentary

San Mateo del Mar

(36 min.)

Interesting and informative description of the difficult lifestyle of the people who live from the sea in Southern Mexico. Where the average family income is \$10 per week. Their diet consists of tortillas with salt fish and 20% of the population has tuberculosis. These are people who desperately struggle to maintain their traditions. Great black and white photography and background music.

Dignity of the Nobodies, The

2005, (120 mins.) O.V. Spanish, English subtitles
Once a thriving country with the agricultural capacity to feed
hundreds of millions, Argentina has been devastated by
exploitation at the hands of multinational corporations and
lending institutions. Stories and testimonials paint a
harrowing picture of globalization, while examples of
organized resistance inspire, as documentarian Fernando
Solana chronicles the struggle of the "nobodies": the
workers, the small farmers and the indigenous people who
are teaming up to fight for their dignity...and for their future.

E EEUU (the U.S.) in Central America

El Salvador- Missing Children

This is the story of the quest to find children who disappeared during the civil war in El Salvador, children who were sometimes sold into international adoption and other times taken into military families.

El Contrato (The Contract)

2003, (51 mins) O.V. English Directed by Min Sook Lee,

El Contrato follows Teodoro Bello Martinez, a poverty stricken father of four living in Central Mexico, and several of his countrymen as they make an annual migration to Southern Ontario. For eight months of the year the town's population

absorbs 4000 migrant labourers who pick tomatoes for conditions and wages no local will accept.

Favela Rising

2007, (82 mins) O.V. Portuguese

This film documents a man and a movement, a city divided and a favela (Brazilian squatter settlement) united. Haunted by the murders of his family and many of his friends, Anderson Sa is a former drug-trafficker who turns into a social revolutionary in Rio de Janeiro's most feared slum. Through hip-hop music, the rhythms of the street, and Afro-Brazilian dance he rallies his community to counteract the violent oppression enforced by teenage drug armies and sustained by corrupt police. At the dawn of liberation, just as collective mobility is overcoming all odds and Anderson's grassroots

Frontera, La (The Border)

2007, (107 mins) O.V. Spanish, English subtitles We've all heard about illegal immigrants but rarely have a chance to learn about their stories from their perspective. La Frontera (The Border) tells the story of illegal aliens through the eyes of a Latin American Director. From the dangerous crossing of the Mexican border to an immigrant's daily struggle in the United States, this film is a rare opportunity to learn why they risk so much in search of the American Dream. La Frontera is entirely based on true stories that were compiled to make up this beautiful and moving film.

Politics of Food

(120 mins) CBC

This two part series addresses the contradiction of the abundance of food produced in the world and the on-going chronic hunger faced by more than one billion people.

<u>Part 1:</u> Presents the example of Sudan where agricultural areas produce sufficient yields for large exports while a large percentage of the population starve. The role of the International Monetary Fund and the World Bank are explored.

Part 2: This deals with the strengths of multinational farming on the dying small farms of North America.

1992, (17 mins)

This video presents the situation faced by Guatemalan refugees in Mexico, such as inadequate water supplies and health problems. The refugees are planning on returning to Guatemala to preserve their cultural identity, despite the ongoing threat of army repression.

<u>Peace, What Peace? Confronting Central</u> America's New Economic War

(29 mins)

During the 1970's and '80s, bloody armed conflicts in Nicaragua, El Salvador and Guatemala drew international attention to the gross inequities and repression that had driven many to rebel. This video reveals a devastating reality the mass media failed to report: the hardships and injustice that led to war have escalated.

Journey with two Canadian high school students to Kenya as they share their experience and gain a better understanding of a different society and culture.

A Place Called Chiapas- Eight Months Inside the Zapatista Uprising

1999, (93 mins)

On January 1, 1994, the day NAFTA came into force, the indigenous Zapatista National Liberation Army took over five towns and 500 ranches in Southern Mexico. Three years later, the Zapatistas and their charismatic leader, guerilla poet Subcomandante Marcos, are trapped in the Lacandon jungle. Surrounded by 30,000 Mexican troops, they struggle to maintain a ceasefire.



G Gift, The

1998, (49 mins) O.V. English
Ever since it was first nurtured from a grass by the Maya, corn has held a sacred place in the lives of Indigenous peoples in the Americas. The video begins in North America on the traditional lands of the Six Nations
Confederacy where we witness the planting of the corn and all the work and that accompany the community harvest.

Greening of Cuba, The

1996, (38 mins) O.V. Spanish, English subtitles
The Greening of Cuba profiles Cuban farmers and
scientists working to reinvent a sustainable agricultural,
based on ecological principles and local knowledge rather
than imported agriculture inputs. In their quest for self
sufficiency, Cubans combine time-tested traditional methods
with cutting edge technology.

<u>Hurricane Mitch—Uncovering the Costs of</u> External Debt

2000, (60 mins) O.V. English

A fine video, courtesy of Deep Dish Television, on the devastation Hurricane Mitch caused in Nicaragua and Honduras in 1998, which was compounded by the enormous foreign debt payments these countries had to make to foreign banks, mostly in the United States. An excellent primer for anyone interested in the Jubilee 2000 campaign for debt relief.



2007, (83 mins)

O.V. English, Spanish subtitles

A Co-production of the BBC and The National Film Board of Canada. Powerful and uncompromising, Killer's Paradise uncovers one of the most emotionally wrenching human rights abuse taking place, the killing of women, while exposing the impunity allowed by an inept judicial system. With its history of almost four decades of civil war, Guatemala is a troubled society but it can also be seen as a microcosm of the pervasive violence and injustice against women that exists in the world today.

L La Amistad (Friendship)

(12 mins) O.V. Spanish, English subtitles Short films made under the project, "Integrated Programme for the Promotion of Sexual and Reproductive Health and HIV/AIDS for Women, Adolescents and young peoples in greater Buenos Aires" in workshops held in conjunction with "Down from Cinema".

One World: Multinationals

1979, (30 mins)

This video shows a pre-NAFTA discussion of the advantages and disadvantages of multinational cooperation in developing countries and Canada. This film provides general information that would still be applicable today.

Padre Pablo

1989, (53 mins)

This video explores the life of Father Harvey Steele and his experiences in developing the credit union and cooperative movement in Central America. We are shown something of his childhood in Cape Breton where the experience of miners and company-owned towns led him to his conviction to bring solutions to similar problems.

The Panama Deception

1992, (90 mins)

This video examines the politics behind the invasion of Panama in 1989 by US forces under George Bush. The impact on civilians, which was ignored or deliberately distorted by the US government's manipulation of the press, is considered by many independent researchers and political analysts. The blatant motives of US power and control of a key position in Central America are revealed and the claim of having resorted democracy to the people of Panama is debunked. The implications of US presence in Panama are briefly discussed, as an entryway into economic control of key South American areas.

Northumberland Voices

(25 mins)

An interesting documentary featuring footage from Cobourg and interviews with many local community activists working in the anti-poverty and labour movements.



Nosotros

2000, (52 mins)

Nosotros, which means "us" in Spanish, pays homage to the women and men who were shaken by Hurricane Mitch in 1998, but who rallied back even stronger than before. This video helps us to relieve the remarkable experience of a few of the Central American communities affected by Mitch, and show us the extraordinary work accomplished there. We view the reconstruction efforts through the eyes of a peasant couple named Marcel and Pompilio.

A controversial, searing and personal story captures both the harsh reality and the haunting dream of a place caught in a waking nightmare.

One World Documentary Series

<u>La Ofensiva Continua</u> (The Offense Continues)

Looking For Justice

2007, (29 mins) O.V. Spanish & English, English subtitles "Looking For Justice" tells the story of the reality of life for coffee farmers in Guatemala, a country devastated by war and inequality, and how one Mayan farmer's movement is using Fair Trade coffee to fund their human rights activism and change the lives of people in Guatemala.

M

Macario, La Tragedia de (The Tragedy of Macario)

2005, (71 mins) O.V. Spanish, English subtitles In 2003, a group of women, men, and children were found dead inside a locked railroad truck along the Mexican-American border (the worst immigrant tragedy in American history). They were undocumented immigrants who, unable to survive the 160 degrees of an enclosure in the Texas heat, died of suffocation. Inspired by that tragedy, this film follows the story of Macario, a young Mexican man who daydreams about coming to the United States but has no money to pay a coyote. An opportunity arrives unexpectedly when he comes across a drug transaction gone bad. Macario takes the money from the dead man and runs away with the others, hiding inside the locked wagon of a train heading north. These events, as well as the highly emotional last minutes of the film, are the most impressive scenes. First-time filmmaker Pablo Véliz (with a modest budget) orchestrates the magical realism of La Tragedia de Macario with a beautiful eye and ear for the inner lives of the truly desperate, while exploring the spirituality they must survive on in place of real food.

Machuca

2007, (115 mins) O.V. Spanish, English subtitles Andrés Wood is a highly regarded Chilean filmmaker, a man unafraid to take on controversial issues and present them in a manner that is revelatory to his audience, whether that audience is in Chile, South American, Europe or North America. In MACHUCA he transports us to the year 1973 in Chile when Pinochet's military coup overthrew Allende, and seized power. Released to widespread acclaim and controversy in Latin America, this film explores Chile's bloody coup through the astonishingly intimate coming-ofage story of a pair of 12-year-old boys. From opposite extremes of society, these boys form an unlikely friendship as politics rip their world apart.

Maria Full of Grace

2004, (101 mins) O.V. Spanish, English subtitles Maria is a Colombian teenager who, for a large paycheck, agrees to be a mule for drug-runners: she has to swallow dozens of thumb-sized capsules of heroin and smuggle them into New York. This debilitating process is painstakingly described, and of course not everything goes as planned when Maria and her fellow mules land in America.

Mesoamerica is Not for Sale

Mesoamerica includes the southwest of Mexico (from Puebla) and Central America (through to Panama). Large transnational corporations have their sights set on the region once again due to its abundant natural resources, cultural and biological diversity. This film demonstrates how local Guatemalan organizations are mobilizing to counter the effects of neo-liberal economic policies and increasing globalization.

México: La Rebelión de la Llorona

1992, (60 minutes) English

This is the story of Mexican women who have fought, and continue to fight, for equality and women's rights. They are women looking for children kidnapped during political pogroms, journalists, writers, and political activists. Machismo and the resulting sexism, as well as Catholicism and its perpetuation of the myth of the Virgin Mary as the standard for feminine behavior, are discussed as social factors contributing to the continued subjugation of Mexican women.

Middle of the World, The

2005, (86 mins) O.V. Portuguese, English subtitles The Middle of the World is a road movie on bicycles. It is freely adapted from the true story of an unemployed truck driver who, with his wife and five children, pedals from Paraíba, in the poverty-stricken Northeast of Brazil, all the way to Rio de Janeiro looking for a job. Romão (the father) feels destined to earn 1000 reais (about 300 US\$) a month – a vast sum for Brazilian standards. On four bikes, the family goes through five states, knows solidarity and indifference, aggressiveness and cordiality. A 2000-mile odyssey through the hinterlands of Brazil all the way to Rio de Janeiro, Brazil's best-known postcard. The Middle of the World shows the quest for the dream of a decent life – a story of dreams and hope.

Missing Young Woman-Señorita Extraviada

2001, (74 mins) O.V. Spanish, English subtitles
The haunting story of the more then 350 kidnapped, raped
and murdered young women of Juárez, Mexico. Visually
poetic, yet unflinching in its gaze, this compelling
investigation unravels the layers of complicity that have
allowed for the brutal murders of women living along the
Mexico-U.S. border.

Mojados

(70 mins) O.V. English and Spanish, English subtitles "Mojados" or "wetbacks," refers to workers from Mexico who illegally cross the border into the United States in order to earn money to send to their families back home. Their stories are, for the most part, little known and little regarded, but with *Mojados*, director Tommy Davis sheds some personal light on this shadowy world. The trip is over a weeklong, with more than its share of hardship. Davis managed to persuade four young men to let him accompany them as they leave their homes, head north toward the Rio Grande, and then cross over into Texas. They don't all make it; and among those that don't, their almost matter-of-fact willingness to go through it all again is remarkable.

Montreal Based Textile Firm & It's Maquila Operation in Honduras

Montaña de Luz

2008, (40 minutes) Closed Captioned

Honduras has the highest rate of AIDS in Central America, and its saddest victims are children and youth. Born to women who are HIV positive, they not only bear the burden of the disease themselves, but many will soon be orphaned, often abandoned to the streets. At Montaña de Luz (Mountain of Light) they find love, care, education, companionship — and most importantly a place where they will not be scorned and discriminated against. At one time the project was thought of as a hospice, where most residents would eventually die, but new anti-retroviral medications mean that these children have a future. The building that was once planned to be the morgue is now a busy and happy computer center.

K

Kanehsatake - 270 Years of Resistance

1993, (119 mins)

A powerful feature-documentary that takes you right into the action of an age-old aboriginal struggle. On a hot July day in 1990, an historic confrontation propelled Native issues in Kanehsatake and the village of Oka, Quebec into the international spotlight and the Canadian conscience. The result is a portrait of the people behind the barricade, providing insight into the Mohawks' spiritual beliefs and fierce pride in their ancestry that governs their unyielding determination to protect their land.

Kilometro Cero (Kilometre Zero)

This documentary details the case that the 1989 invasion of Panama by the US was motivated not by the need to protect American soldiers, restore democracy or even capture Noriega. It was to force Panama to submit the will of the United States after Noriega had exhausted his usefulness.

Patricia

2005, (63 mins) O.V. Spanish, English subtitles Patricia is a young Bolivian university student and like all people her age, she likes to be in love, to study, have friends and dance. However, after a one-night stand at a party, after drinking, her life is changed forever.

Peace, what peace?

During the 1970s and '80s, bloody armed conflicts in Nicaragua, El Salvador and Guatemala drew international attention to the gross inequities and repression that had driven many to rebel. Today, peace agreements have been signed and the fighting has ended, but so too has much of the international attention.

That's why the inter-Church

Committee on Human Rights in Latin America journeyed back to the region to film what has happened since. The film reveals a devastating reality the mass media has failed to report: the hardships and injustice that led to war have

escalated, not diminished. Telling the moving stories of men, women, and children, this video helps viewers understand the economic policies which are now the greatest threat to human rights in the region—policies supported by northern countries like Canada.

POV: Farmingville

2003, (73 mins) O.V. English

A provocative, complex, and emotionally charged look into the ongoing nationwide controversy surrounding a suburban community, its ever-expanding population of illegal immigrants, and the shockingly hate-based attempted murders of two Mexican day laborers. In the late 1990s, some 1,500 Mexican workers moved to the leafy, middle-class town of Farmingville, population 15,000. In some ways, it's a familiar American story: an influx of illegal immigrants crossing the border from Mexico to do work the locals won't; rising tensions with the Anglo population; charges and counter-charges of lawlessness and racism; protest marches, unity rallies and internet campaigns-then vicious hate crimes that tear the community apart.

Quinceañera

2007, (91 mins) O.V. Spanish, English subtitles The story follows the travails of young Magdalena (Emily Rios), a teen in the Mexican-American, but gentrifying, Los Angeles neighborhood of Echo Park. As Magdalena's 15th birthday approaches, and the festive coming-of-age *quinceañera* party that accompanies it, life throws her a curve ball in the form of an unexpected-and possibly Miraculous-pregnancy.

<u>Hands of Canadians: Towards a New Constitution, The</u>

When The Mountains Tremble (New Version)


